Cartage (Store Door) Delivery: Transportation
charges incurred from the nearest common carrier
point to final destination or to ship side (in case of

In case the product or any part thereof furnished hereunder is in any suit or proceeding so defended held to constitute infringement, and its use is enjoined, Westinghouse shall, at its own option and its own expense, either: procure for the purchaser the right to continue using said product or part thereof; or replace it with a non-infringing product; or modify it so it becomes non-infringing; or remove it and refund the purchase price and the transportation and installation costs thereof.
